4. All seeds are packed in different packing sizes on **“AS IS WHERE IS BASIS”**. The arrangements for lifting the seeds will be made by the Tenderer at his own cost. The cost of removing tags, labels, seals & defacing of bags will be borne by the Tenderer and Area Manger concerned should be advised to remove all tags, labels and seals before delivery. The stocks shall be supplied only after removing tags, labels, seals etc in open condition. If tenderer wants to lift the material with bag, he should deposit Rs.3/- per bag and after returning the bag in good condition Rs.3/- will be refunded otherwise this amount will be forfeited.
