**TERMS AND CONDITIONS FOR PROCESSING , PACKING AND MAINTENANCE OF
BENGALGRAM SEEDS**

National Seeds Corporation Limited, Central State farm Jawalgera, invites sealed tender from the reputed and seed Certification agency approved seed processing plant owners, herein after called as Tenderer in two bid system for processing, packing and tagging of certified seeds of Bengalgram in NSC bags including maintenance of stocks and insurance in the name of NSC for the period of 6 months Offers are to be quoted as detailed below

TWO BID SYSTEM:

1 ENVELOPE NO.1(SEALED)

This envelop should be marked as “ENVELOPE No.1 TECHNICAL BID for processing of seeds and should contain papers (format enclosed) with covering letter on letter head (Tenderer should invariably mention their name,. Address, etc on left hand side of envelop for clear identification) as format enclosed.

2 ENVELOPE NO-2.(SEALED)

This envelope should be earmarked as ENVELOPE NO.2 FINANCIAL BID processing of seed should contain PART “B” (tenderer should invariably mention their name address etc on left hand side of envelope for clear identification).

Both the envelopes should be contained in one big sealed envelope superscribing therein “tender for processing of seeds”. The sealed tender should be delivered in the office of the Head of the Farm, NSC, Central State Farm Jawalgera Tq. Sindhanur Dist Raichur,Karnataka. Tenderer must affix seal and put address on each envelop.

TERMS AND CONDITIONS.

- 1) Rate shall be quoted in Rupees per qtls. The rate shall be inclusive of all taxes if any applicable.
- 2) The tender shall be accompanied with the EMD of 15000/-, in the form of Demand draft in favour of “**National Seeds Corporation Ltd**”, payable at **Sindhanur**. The EMD of successful bidder will be converted as security deposits and will be refunded after completion of all works without any interest. If the work was not done as per the terms and condition of the NSC, the amount of security will be forfeited.
- 3) Tender in sealed envelope will be received at National Seeds Corporation Limited, Central State Farm Jawalgera upto 1.00 PM on 28.3.2018. The technical bids will be opened on the same date at 3.00pm. in the presence of those tenders or their representatives who may wish to be present. Financial bids will be opened for those whose technical Bid will be in order and at 3.30 pm on the same day. Tenders received after the due date and time will be rejected.
- 4) Processing plant should have the license issued by the APSSCA for processing and storage godown.

- 5) Processing of seed is to be carried out as per the directions of Officials of certification agency and NSC Ltd Central State Farm Jawalgera. The quantity of seed to be processing may be changed as desired by NSC.
- 6) The rates quoted for processing charges should be inclusive of unloading of raw seeds receiving from farmers, processing, packing, maintenance of seed stocks.
- 7) The required gunny/cloth bags, thread spools, lead seal and tags for packing will be supplied by NSC Central State Farm Jawalgera.
- 8) The processing plant & Godown should have been insured against fire/theft of seed in the name of NSC. The insurance policy is to be purchased by party in favour of NSC CSF Jawalgera on his cost for the quantity stored with them.
- 9) All the expenditure in maintaining the seed healthy and insect free will be borne by the tenderer (party) only.
- 10)The tenderer (party) should arrange the Certification process; however the actual charges for sampling, supervision and tags would be borne by NSC on production of bill from certification agency.
- 11)The processing of seeds has to be taken up as per the guidelines of officials of NSC, Central State Farm Jawalgera. In case of delay in packing of seeds by the party, the authorities of Central State Farm Jawalgera will arrange packing at its own and the expenditure so incurred will be deducted from the bills of the party.
- 12)The seeds are to be stored up to 6 months and if the seeds are to be stored after 6 months, the rental charges will be paid at par with CWC rate. During such period insurance policy is to be purchased by party in favour of NSC CSF Jawalgera on his cost.
- 13)Payment of the party will be made through Cheque/NEFT/RTGS after completion of processing & packing.
- 14)The taxes will be deducted as per rule.
- 15)The officials of APSSCA and Central State Farm are to be allowed for inspection at any time during the period of processing and storage.

ARBITRATION CLAUSE

All dispute arising out of this contact between the parties here to, shall be reoffered for the arbitration to the Chairman cum Managing Director, NSC Ltd New Delhi. The Chairman Cum Managing Director NSC New Delhi or his nominee will be the sole arbitrator and whose decision shall be final, conclusive and binding on both the parties.
