- ➤ **NSCL e-Procurement Portal:** An e-tendering portal of National Seeds Corporation Limited ("NSCL") introduced for the process of e-tendering which can be accessed on <a href="https://indiaseeds.eproc.in">https://indiaseeds.eproc.in</a>.

#### I. ACCESSING / PURCHASING OF BID DOCUMENTS:

- It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency (Bidders can see the list of licensed CA's from the link <a href="www.cca.gov.in">www.cca.gov.in</a>) to participate in e-tendering of NSCL.

- 2. <u>Work Experience</u>: Experience of civil work will be counted 40% of three works, 50 % two works and 80 % one work of similar nature in last seven years. Experience other than similar nature will not be accepted.
- 3. <u>Bids</u>: <u>Technical bid</u> contains uploading of self-attested copies of all desired documents i.e EMD Proof, Firm Registration for Electrical works/ Electrical Supervision Permit, pan card, work experience, Bank account detail/status of firm ,GST no., ESI, EPF Registration will also be required. <u>Tender not accompanied</u> with requisite document are liable for rejection.
