### CIRCULAR

**Subject:** Reimbursement of medicals claims under OPD in r/o CGHS card holders.

As you are aware that reimbursement of medical claims for OPD to all the employees of the Corporation are being processed/passed as per NSC Medical Attendance Rules. The employees posted at Corporate Office have the option to choose for reimbursement of medical claims under OPD as per NSC Medical Attendance Rule or for CGHS Card. As per existing practice the consultancy charges and investigation/pathological tests (if referred by CGHS dispensary) under OPD treatment in respect of CGHS card holders are reimbursed without limits. However, there is annual ceiling/limit for reimbursement of medical claim under OPD (except for special disease) in respect of employees of corporate office opted as per NSC Medical Attendance Rules.

To remove the disparity in reimbursement of medical claims under OPD treatment at Corporate Office, following has been decided:

- (a) An amount of Rs. 15,368/- only (at present) for making/renewal of CGHS card will be recovered from the employees opted for the CGHS Card @ 1500/- per month in 09 installments and Rs. 1868/- as final installment from the salary starting from the month of April every year.
- (b) The ceiling/limit of one month basic pay or Rs. 30,000/- whichever is less for OPD treatment as per existing NSC Medical Attendance Rules, will now be applicable to CGHS Card holders for reimbursement on account of consultancy charges, investigations/pathological tests etc., (if referred by CGHS Dispensary)..

The reimbursement of medical claim under OPD treatment in respect of remaining employees at Corporate Office to be continued without any change as per NSC Medical Attendance Rules.

The above changes will be effective from 01<sup>st</sup> April, 2023.
