I. ACCESSING / PURCHASING OF BID DOCUMENTS :

- It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency under CCA, Ministry of Electronics and Information Technology, Government of India to participate in e-tendering portal of NSCL. Bidders can see the list of licensed CA’s from the link www.cca.gov.in C1 India Pvt. Procedure for submission of tender:

Each Tenderer shall submit in two parts.

1. TECHNICAL BID:

The TECHNICAL BID shall be submitted as per PART-A, this contains the details of organization, company profile, details of experience, EMD etc.

2. FINANCIAL BID

The Financial Bid for custom processing, packing and storage of seeds. **Each Tenderer has to quote financial offers on per quintal basis for cleaned seed as per PART-B in e-portal.**

Section-I

GENERAL TERMS AND CONDITIONS OF CONTRACT

1. The tenderers are advised in their own interest to carefully read the tender document and understand their purport and unless the tender specifically states to the contrary in respect of any particular clause, it shall be presumed that he accepts all the terms & conditions as have been laid down in the tender document and submit the tender accordingly.
2. Tenderers interested to quote against this tender must quote for **Processing, Packing and Storage of Seeds as Mentioned in NIT. Party should have experience in the processing and packing work with required facilities such as machinery, storage space and Labors.**
3. **SUBMISSION OF OFFER:** - Offer must be submitted **online under Two Bid System**. The tenderer may upload additional documents wherever detailed description is necessary. **Only that party should tender who accepts all the terms and conditions because conditional tender may be treated as void.**
4. **QUOTATION OF PRICES:-**
 - i. The tenderer has to quote processing charges on good seed basis for processing, packing and storage of seeds.
 - ii. Tenderer shall give final firm and net per unit price free from all escalation. Request for increase in price will under no circumstances be considered after opening of the tender. For the purpose of comparison and evaluation of bids, the tenderers are required to quote the rates for entire work inclusive of all taxes and charges such as cleaning, packing, stacking, storage etc.
5. The tender shall be accompanied by interest free EMD of Rs. 15000.00/- through NEFT/RTGS after generating E- Challan from <https://indiaseeds.eproc.in>. Tenders without EMD may be rejected. After finalization of L1 rates, the tenderers will be asked to give their acceptance for the same. EMD of those tenderers who will not give their acceptance will be released within 30 days of finalization of tender process. Whereas EMD of those tenderers who will give their acceptance will be returned after the entire deal is over. Outstanding amount, if any, of the tenderer with NSC will not be considered for the EMD purpose.
6. Indian manufacturers / suppliers who are Micro Small Medium Enterprises (MSME) Small Scale Units and registered with National Small Industries Corporation under single point registration scheme are exempted from payment of Earnest Money and tender cost deposit provided they furnished photo copy of valid registration with NSIC under the single point registration scheme, for the quoted stores in support of claim along with their request letter. This facility will, however, will not be provided to those small scale units who are registered under the old registration scheme which were extended upto 30th June, 1981, only. In this regard a written request is to be made by the bidder. However, successful tenderer have to deposit the Security Deposit.

7. Tenders may upload their bid up to 2.00 PM on 03.03.2022 and technical bids will be opened on the same date and place at 3.00 PM in the presence of those Tenderer who may wish to be present. The hardcopies of technical bid have to be submitted on or before 03.03.2022 at 3.00 PM without fail (**Hard copy submitted will be considered only for cross verification of the documents submitted online, if needed**). Financial Bids will be opened for those whose Technical Bid will be in order as per NIT. Tenders received after the due date and time may be rejected.

8. Period of Contract:

This contract will be for a period of one year (Extendible upto one year) and if mutually agreed it can be extended for further one year at the same rates and same terms and conditions.

9. If any information provided by the tenderer in both Technical bids and Commercial bids is found to be factually false or misleading, such tenders will be summarily rejected at any time during the validity of the tender and liable for criminal and civil action against such firm or company.

10. EMD of the tenderers, who will give their acceptance for finalized rates, will be adjusted as security deposit and will be released only after completion of total transactions.

11. The tenderer who will give his acceptance for finalized rates shall at his cost execute an Agreement with NSC on Rs.100/- non-judicial stamp paper of required value for arranging the processing, packing and storage of seeds as per the Terms and Conditions sign each page of the Terms & Conditions and submit the same to NSC.

12. FORFEITURE OF THE EARNEST MONEY:-

Earnest Money may be forfeited in the following circumstances.

a) If a tenderer withdraws its tender during the period of Tender validity specified by the Tenderer on the Tender Form:

OR

b) In case of a successful Tenderer, if fails to sign the contract in accordance with clause no.10

13. AWARD CRITERIA:-

The bidder has the facility of Seed storage godown of **2000 qtls** minimum in addition to processing facility and having at least **100 qtls** daily processing and packing capacity.

14. NSC's RIGHT TO VARY QUANTITIES AT TIME OF AWARD: - The Corporation reserve the right at the time of award of contract to increase or decrease the quantity as per requirement or to cancel the entire work specified in the schedule of requirements without any change in price or other terms & conditions.

15. NSC's RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS:-

The Corporation reserves the right to accept or reject any or all Bids, and to annul the tendering process and reject all Bids any time prior to award of contract, without thereby, incurring any liability to the affected tenderer or tenderers or any obligation to inform the affected tenders of the grounds for the Corporation's action.

NSC reserves the right to terminate the contract of processing at any time with one month's notice to the Custom Processor/ Contractor or immediately if the work found unsatisfactory in matter quality, Grading, handling and packing etc.

16. NEGOTIATION: - As the tender is for finalization of rates contract, there will be negotiation on L-1 rates with all the eligible bidders and work order will be issued on the negotiated & accepted rates for processing & packing of seeds.

17. Award of work: - As the processing and packing of seeds to be taken up nearby at our production Areas, the work order will be given to different parties at negotiated L-1 Rates for different quantity. The quantity for processing & packing may vary from location to location in accordance with production at our different seed production plots.

18. Amendment - NSC reserves the right to amend or change terms and conditions upon giving due notice to them as and when required and the same will be binding upon the contractor.

19. Default & Risk Clause:

(a) Should the Custom processor in any manner or other-wise fail to perform the job order or if fails to complete the order in time according to the specifications or should it have winding up the order made against it or make or enter in to any arrangements or composition with its creditor or suspend payments (or being a company should enter in to liquidation either compulsory or voluntary) the Corporation shall have power under the hand of Regional Manager to declare the contract at the end at the risk and cost of the custom processor in every way. In such case custom processor shall be liable for any liquidated damages for delay as above provided and for any expenses, losses or damages which the Corporation may be put in or incur or sustain by reason of, or in connection with custom processor default.

(b) The cancellation of the contract may be either for whole or part of the contract at Corporation's option. In the event of the Corporation terminating this contract in whole or in part, it may take up the work in such a manner as it deems appropriate custom processing similar to these so terminated and the custom processor shall be liable to the Corporation for any excess cost for such similar works provided that the custom processor shall continue the performance of this contract to the extent not terminated under the provisions of this clause.

20. Force majeure:-

Notwithstanding the provisions of Clause 18, the custom processor shall not be liable for forfeiture of its Security Deposit, liquidation damages or termination for default, it and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force majeure.

For purposes of this Clause, "Force Majeure" means an event beyond the control of the custom processor and not involving the custom processor's fault or negligence and not Foreseeable. Such events may include, but are not limited to, acts of the Corporation either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

If a Force Majeure situation arises, the custom processor shall promptly notify the Corporation in writing of such conditions and the cause thereof within 48 (Forty-Eight) hours. Unless otherwise directed by the corporation in writing, the custom processor shall continue to perform its obligations under the Contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

21. ARBITRATION & SETTLEMENT OF DISPUTES:

In case any dispute arises between the NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon the parties to resolve issue under the provision of Arbitration and conciliation Act, 1996 as amended from time to time. Under this provision, the Chairman-Cum-Managing Director, National Seeds Corporation Limited with the concurrence of both the parties shall appoint sole arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve the dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall in English Language. The court of Delhi shall have the jurisdiction.

Section-II

National Seeds Corporation Limited, Chennai is interested to get the processing of **various crops such as Paddy and Blackgram**, which are produced in this region and to be processed on custom basis. The tender is invited from the reputed and experienced Custom Processors/Contractors, who have processing facility such as Seed Storage godown, Seed Processing Machinery like Seed Cleaner cum Grader, Gravity Separator, Seed Treater, Weigh Bagger, Sealer, Moisture Meter, bag closer, back up electric supply by Generator etc., The custom processor should have trained and professional man-power for operation and management of seed processing plant. The processing Plant should be registered with the State Seeds Certification Agency and License should have been renewed with sufficient validity period.

1. Quantum of seeds for processing:

- i. It is expected that the sizeable quantity of fresh stock may be available in Rabi 2021-22. The quantity can vary depending upon the season and vagaries of nature. NSC will first utilize its own capacity then quantity will be spared to Custom Processors, so quantity for processing can vary according to the availability and requirement of seed in a season.
- ii. NSC does not take guarantee to provide the quantum if availability is affected by natural factors/ any other decision of the management.

iii. Custom Processing work has to be got done by the following Area Office/locations:

- i) Madurai
- ii) Coimbatore
- iv. The quantity at each plant will vary according to the arrival of raw seed. The location of the Seed Processing Plant should be around production area convenient for transportation of raw seed by NSC seed growers. NSC may allot in case of more quantity and rate difference the quantity at Seed Processing Plant to more than one custom processor in one district/location.

2. Eligibility as a Custom Processor/Contractor:

- i. The processing Plant should be registered with respective State Seed Certification Agency and License should have been renewed for the current year or having suitable validity.
- ii. The Custom Processor/ Contractor should be experienced in carrying out custom processing and packing of all kinds' seed and experienced party shall be given preference.
- iii. The Custom Processor/ Contractor should have seed processing machinery like Seed Cleaner cum Grader, Gravity Separator, Seed Treater, De-stoner, Elevator, Weigher Bagger, Sealer, Moisture Meter, bag closer etc. in good condition and having capacity of two to four tons per hour so as to complete the processing of above quantum of seed. The make of the machinery must be from the reputed companies.
- iv. The Custom Processor should be able to complete the processing of seeds within time limit given as availability of seed timely for marketing is a crucial parameter for NSC.

v. The Custom Processor should have sufficient trained and professional man-power at the plant. The staffs has to be available and if required for running the plant in three shifts, additional qualified and experienced staff will have to be engaged by the Custom Processor/Contractor if there is need to complete the processing and packing.

vi. It is the responsibility of the Custom Processor/ Contractor to arrange Generator Set in case electric power supply is off, delay in processing on account of power off will not be tolerated and it will be penalized. Therefore, Custom Processor/ Contractor have to arrange Generator Set either on rent or his own for running the plant.

vii. The Custom Processor should be able to run the plant by engaging labors/ handling labors and professional staff with the minimum pay and allowance as applicable as per Government rules and regulations and various Acts and provision of Laws. It will be the responsibility of the **Custom Processor/Contractor to produce all the records to the Government authority like Factories Inspector, Labor Inspector, Statistical Department, Pollution Control Office, Shops and Establishment Office, Weights and Measures Office etc. There shall be no liability of the Corporation on this account.**

viii. **The Custom Processor/ Contractor should have registration with Assistant Commissioner of Labors for engaging labors and also registration from Shop and Establishment Office.**

ix. The Custom Processor / Contractor should have GST Registration, Professional Tax registration and PAN card.

x. The custom processor should have the good facilities for seed processing and storage of seed. The processing plant should be in good condition i.e. proper cleaning, ventilation, space etc. & following the standard requirements.

xi. The processing plant building & Seed Storage Godown should have well protected premises either by wall or fencing.

xii. Required number of male and female labors and additional labors should be made available for processing work.

xiii. The Custom processor/ contractor should run plant in two or three shifts as per the processing load allotted by NSC to complete the processing within time limit given. In case of load shedding/ continuous power failure the custom processor / contractor should run the plant by using DG set either owned or hired so that processing should be completed within time limit given by NSC. NSC will not provide DG set, diesel, oil etc. neither will bear any extra expenditure.

xiv. The custom processor should have the insurance against fire, theft and burglary and also responsible for arranging sufficient safety system for seeds stored inside the processing plant and godown as well as for the workers working under this contract. In case of any eventualities, the compensation given by the insurance company has to be extended to the National Seeds Corporation Ltd., to the extent of loss incurred by NSC. NSC will not be responsible for any workmen compensation, in case of any eventualities.

3. The quality of the seed in the storage and at the time of processing has to be maintained well as per the directions of NSC officers posted at the plant. All the standard procedures of Seed Certification agency have to be followed while processing. The custom processor should allow technical staff of NSC to monitor the processing and packing of seeds at any time.

4. The custom processor should allow the concerned grower at the time of processing as per the request of NSC Technical staff and should hand over all the undersized and rejected seeds to the growers as per the direction of technical staff of NSC only.
5. The custom processor should return all unused packing material and labels of NSC after completion of processing and packing.
6. All records related to seed processing and stock details are to be maintained by custom processor as per the rules and regulation of certification agency.
7. Sufficient Security/ watch and ward have to be provided by the Custom Processor/ Contractor. No charges will be provided by NSC for this.
8. Custom Processor/ Contractor or his authorized representative should always be present in the plant to attend to the problems of seed growers, labors, handling laborers and to attend the works allotted by Seed Certification Agency and NSC officer pertaining to processing and packing of NSC seeds.
9. The processing and packing of seeds are to be done as per schedule given by technical staff of NSC and in case of delay, penalty @ **Rs. 10/- per quintal per day will be charged** to the Custom Processor/ Contractor for a period of fifteen days and thereafter seed stock will be removed from the plant and it will be processed either at NSC own plant or at other plant and full amount of processing expenditures, transport and handling expenses incurred will be recovered in advance from the default custom processor.
10. **The seed stock is to be maintained in good condition and arrange fumigation, spraying and dusting in the premises where NSC stock is kept. The custom processor has to maintain cleanliness and the sweeping will have to be carried out by Custom processor on time to time by their own arrangement.** Any damage to raw seed or seed stored in the processing plant / godown and loss there off will be recovered from the custom processor by NSC. In case the Custom Processor delivers the seeds of NSC to any grower or any party without the presence of technical officer of NSC.
11. It will be the responsibility of Custom Processor/ Contractor to provide sufficient staff, labors and handling labors to run the plant and to maintain the records and management and operation of plant. NSC will depute a technical official only for supervision and all the processing and packing works to be carried out only in the presence of NSC Technical official.
12. The Custom Processor/ Contractor should keep good liaison with Seed Certification officers and all concerned Government Officers.
13. There should have no mortgage for NSC seeds stored in the godown of Custom Processor's Godown at any stage, from any financial institutions.
14. **Payment terms:**
 - a) The custom processing invoice bills should be submitted through concerned Area Offices and payment will be made through RTGS from Regional Office, Chennai.
 - b) The payment will be released for **graded and packed quantity** after completion of processing and packing and, after taking stock to NSC custody.
 - c) While submission of bills the custom processor should ensure to return all the material such as processing, packing & certification materials etc. with their account to NSC and Certification materials to SCA. Also all records like Control Register, tagging register, tag account register, Gate pass and Release order etc. should be handed over to NSC and SCA.
 - d) **TDS or other charges as applicable on each bill amount will be deducted from each bill.**

Instructions for custom processor:

1. Processing rates:

The processing rates will include following components:-

- i. Writing Grower's name, receipt number, lot number etc. on each and every gunny bags of raw seed. Required ink, color will have to be arranged by Custom processor/Contractor.
 - ii. Assist to NSC Officials in drawing the sample from each and every bag while unloading. Custom processor/Contractor will have to use his own sampler.
 - iii. Assist to NSC Officials in checking moisture content of lot. Custom processor/Contractor will have to use his own moisture meter.
 - iv. Assist to NSC Officials in bifurcation of sample and preparation of sample by putting sampleslip inside sample bag, stitching of sample bags etc. to send to STL. Sample bags will be provided by National Seeds Corporation Ltd. Stitching/sewing machine, thread, stamps etc. will have to be provided by Custom processor/Contractor.
 - v. Processing of raw seed i.e. lot wise grading of raw seed on air screen seed cleaner, gravity separator, spiral separator, seed treatment (slurry or dry). If National Seeds Corporation Ltd desire to put treatment materials like Thirum inside the good seed bags, then the packets of the same will have to be prepared by Custom processor/ Contractor. No separate charge will be given for the same. Empty packets will be provided by National Seeds Corporation Ltd for packing.
 - vi. Weighing of good seed and low grade, stitching of good seed bags either with tags and labels or without tags and labels, outer packing in case of small size packing, stitching of low grade gunny bags, stacking of good seed and low grade bags, printing tags and labels, good seed bags with all required matter. Writing lot number and weight on low grade gunny bag, bundling of empty gunny bags. Writing and maintenance of all records i.e. control register, grading/shift register, tagging register, history register, and any record as per directives of National Seeds Corporation Ltd representative and SCA.
 - vii. MRP and other matter printing on good seed bags as desired by National Seeds Corporation Ltd.
- 2.** Cleaning and sweeping of plant and godown charges will not be paid by NSC and it is the responsibility of the Custom Processor/Contractor to engage labors for this operation
- 3.** Entire certification charges will be paid by NSC.
