SECTION-II

TERMS & CONDITIONS OF THE CONTRACT

1. The tenderer/bidder should have at least 02-03 years experience of construction of Green House. Supporting documents i.e. work order/proof of completion must be uploaded in proof.
2. Description of items is given at Annexure-A-2 of Section-I, Part B . The materials, Electrical fittings/equipments etc. should be of reputed brand, and as per standard make/ISI Standard/I.S.code/ISO.
3. The tenderer should read the specifications, terms & conditions of tender carefully before submitting tender.
4. The tender must be submitted in online as per instructions given in the tender document.
5. The earnest money and Tender Fee should be submitted online along with tender documents.
6. Micro small & medium enterprises MSME's registered with NSIC or any other body specified by Ministry of MSME, for such works are exempted from payment of Tender fee as well as EMD. Security deposit however, will have to be deposited in the case of grant of work.
7. The tenderer before submitting their bids, may visit site on any of the working day from 10.00 am. To 5.30. pm. at given address.
8. The contractor will have to give an undertaking that he will submit the proof of remittance of PF through challan at the time of bill payment. In case of non furnishing of such proof, 4.7% (four point seven percent) of the value of the bill amount of work shall be withheld by NSC which can be released only after production of the required document.

If it is incumbent upon NSC to deposit withhold amount with EPF authorities, the same shall be deposited by NSC with EPF authorities. After deposition of the amount, NSC shall not refund this to the contractor even on production of EPF Challans.

9. NSC shall also recover labour Cess @ 1% from each RA bill and shall deposit with the Labour Board of the concerned state. In case the Labour Board is not established in the state, recovery made by NSC shall be retained under suspense and will be deposited with the Labor Board as & when established in the state.

10. GST or any other tax applicable on material in respect of this contract shall be payable by the contractor and no claim whatsoever in this respect will be entertained.
11. Time allowed for carrying out the work will be 120 Days.
12. Tenders must be submitted online up to 20.04.2022 ,15.00 hours and Technical bids will be opened at 15.30 hours on same day at above mentioned address in presence of tenderer who wish to attend.
13. Tender should remain open for acceptance for a period of 90 days from the date of receipt of tender. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which are not acceptable to the department, then the corporation shall, without prejudice to any other right or remedy, be at liberty to forfeit the earnest money as aforesaid.
14. Tenders who do not fulfill all or any of the above conditions or incomplete tenders in any respect are liable to be summarily rejected.
15. The tenders containing unsealed remarks or any additional conditions are liable to summarily rejection.
16. Mobilization advance shall not be applicable.
17. The contractor should visit the site and shall satisfy himself to the conditions, the accessibility of site, the full extent and character of operation, the nature of the ground and supply conditions affecting lay out execution of the contract generally. No claim on the ground for want of knowledge in such respect will be entertained.
18. Change in the terms and condition or the specifications, or schedule of completion shall not be accepted such conditional tenders shall be liable for rejection.
19. Cutting/overwriting in the offer must be avoided as may be lead to cancellation of Tender. However in the case of any cutting, it should be authenticated by signature of the tenderer concerned.
20. The rates shall be inclusive up to all heights, materials, labours, tools & plants and taxes etc. as per site condition.
21. The contractor shall give a list of NSC employees related to him.
22. The successful tenderer shall deposit performance Bank guarantee @ 03% of accepted value of work within 15 days of letter issued in this regard.

This guarantee bond shall be in the form of Demand Draft or by means of Bank Guarantee as per proforma attached at Section-IV Part-A of the tender document. The Bank Guarantee shall issued by any Nationalized Bank only. The Bank Guarantee should be accompanied by a forwarding letter of the banker on their letter head. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 days beyond that. In case the time for completion of work gets enlarged, the

contractor shall get the validity of performance guarantee extended to cover such enlarged time for completion of work. After recording of the completion of certificate for the work by the competent authority, the performance guarantee shall be returned to the contractor, without any interest.

23. The **security deposit** shall be dubitable @ 10% from the bills and will remains as such for a period of defect liability from the date of completion of work. **Defect liability period will be twelve months.**
24. Defects arising during the defect liability guarantee period if any shall be rectified by the party free of cost with in fortnight as and when brought to the notice in writing or telephonically.
25. The contractor's responsibility for this contract shall commence from the date of issue of order of acceptance of tender.
26. The contractor shall maintain and produces all records when called for, related to relevant Acts concerning labour engaged and construction.
27. An affidavit on Rs.100/- non-judicial stamp paper stating that the firm is not black listed by Govt. Deptt./ Public Enterprises/ Govt. Undertaking etc. in prescribed format given at Annexure-A-1.
28. **Agreement:** The successful tenderer shall, within 15 days of having been called upon by notice to do so, be bound to execute a formal agreement as per the format given in Section-V of Part-A of the tender document. The terms & conditions contained in Section-II of Part-A of the tender document will be construed to be part of the agreement. Any variation in the terms & conditions as may be suggested by the tenderer and accepted by the Corporation will be specifically mentioned in the agreement. The cost of stamping for agreement should not be less than Rs.100/- which shall be borne by the successful tenderer.

29. **Refund of Earnest Money:**

A. Unsuccessful Tenderers

In case of unsuccessful tenderers who do not withdraw their offers before the receipt of final decision, the earnest money shall be returned without interest after the finalization of tenders.

B. Successful Tenderers

After the successful tenders have completed all formalities as stated, the earnest money deposit shall be refunded to him.

30. **Forfeiture of Earnest Money:**

In the event of a tenderer, whose tender is received within time, withdraws his tender before the receipt of the official decision or a tenderer whose tender has been accepted fails to (I) execute the contract (ii) furnish Security-cum-Performance Guarantee Bond after such acceptance is made known to him, the earnest money deposited by such tenderer shall be forfeited and in the later case the acceptance of the tender shall also be revoked.

31. All the disputes or differences that may arise in connection with this tender or the interpretation of any of its terms or in any other way related to this tender directly or indirectly shall be referred to arbitration in accordance with the clause relating to settlement of disputes included in Section-II of Part-A of tender document (General terms & conditions of the Contract).

32. INSPECTION

Inspection of work will be undertaken during the progress of said work.

33. REMOVAL OF DEFECTS

If upon inspection, any defects of whatsoever nature, are pointed out by the Corporation/ Purchaser or his nominee, it shall be the duty of the supplier to rectify the same as far as they are within the specification mentioned in the supply order within 2 weeks from the date of communication of defects. The date of receipt after removal of defects will be construed as date of receipt for the purpose of calculating delivery period.

34. LIQUIDATED DAMAGES

Time of work completion stipulated in the contract is the essence of the contract. It is admitted by the supplier/contractor that any delay in the work completion will cause damages to the corporation/purchaser, the supplier/contractor hereby agrees that the corporation/purchaser shall suffer damages at the rate of 0.5% (half percent) of the contract price per week of delay, subject to maximum of 10% of the contract price and it shall be deemed to be the actual damage suffered by the corporation/purchaser. The supplier/contractor undertakes that if it fails to have complete the work at site by the time specified in the order, the supplier shall become liable to pay damages at the above rate and shall continue to incur liability to pay damages as the delay increases. The corporation may withhold any payment due to the supplier/contractor until the whole of the equipment have been fully supplied, delivered and installed and may deduct or recover from the supplier/contractor liquidated damages as stipulated above.

35. DEFAULT AND RISK PURCHASE

Should the supplier fail to have the store ready for delivery as aforesaid, or should be supplier in any manner or otherwise fail to perform the contract or should it have receiving order made against it or make or enter into any arrangements or composition with its creditor, or suspend payment (or being a company should enter into liquidation either compulsory or voluntary) the Corporation shall have power under the hand of the Chief Executive, to declare the contract at end at the risk and cost of the supplier in every way. In such case supplier shall be liable for any liquidated damages for delay as above provided and for any expense, losses or damages which the Corporation/Purchaser may be put to incur or sustain by reason of, or in connection with supplier's default.

The cancellation of the contract may be either for whole or part of the contract at Corporation's option. In the event of the Corporation terminating this contract in whole or in part, they may procure upon such terms and in such manner as they deem

appropriate, supplies or services similar to those so terminated and the supplier shall be liable to the Corporation for any excess cost for such similar supplies or services provided that the supplier shall continue the performance of this contract to the extent not terminated under the provisions of this clause.

36. CORRUPT GIFTS AND PAYMENTS OF COMMISSION

Any bribe, commission, gift or advantages given, promised or offered by or on behalf of the supplier, his agents or representatives or anyone on their behalf to any employee, representative or agent of the Corporation/ or any person on his behalf in relation to the execution of this or any other contract with the Corporation shall, in addition to the criminal liability under the laws in force, subject the supplier's cancellation of this and other contracts with the Corporation, and also to payment to any loss resulting from any such cancellation to the extent as is provided in case of cancellation under Clause 'DEFAULT AND RISK PURCHASE' and the Corporation shall be entitled to deduct the amounts so payable from any money otherwise due to the supplier under this or any other contract.

37. TERMS OF PAYMENT

- i) On completion of work and inspection by the Corporation, invoice shall be prepared in duplicate in favour of National Seeds Corporation Ltd., Area Office, Bhubaneswar and shall be signed by the supplier. Every invoice shall bear a certificate that the **"material covered by the invoices has been inspected by the supplier before delivery and conforms in every way to the contract specifications and further that no invoice has been preferred previously in respect of the articles charged in the particular invoice"**.
- ii) 50% Payment shall be made after successful completion of work and balance 50% will be released after 30 days of the supply and installation put under satisfactorily trial of supplied and installed items of the Green House.

38. SETTLEMENT OF DISPUTES

All disputes or difference in relation to the contract or the interpretation of any of its terms of implementation thereof or arising out of the or concerned directly or indirectly with the contract shall be referred to the Arbitration of a single Arbitrator to be appointed by the Chairman-cum-Managing Director of the Corporation and in the absence of CMD, highest Executive officer of the Corporation shall make such appointment. The venue of Arbitration shall be New Delhi/Delhi. If for any reason the matter has to be referred to a Court of Law, the Court of Law at New Delhi/Delhi or the Court of Law having its jurisdiction at New Delhi/ Delhi only shall have jurisdiction in this matter. The arbitrator(s) shall have power with the consent of the parties to extend the time for making and publishing their award.

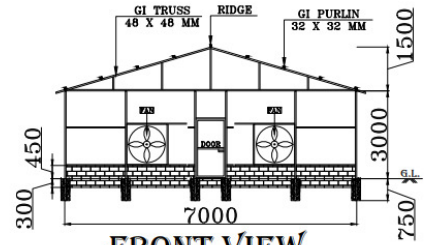

Green House Layout Design

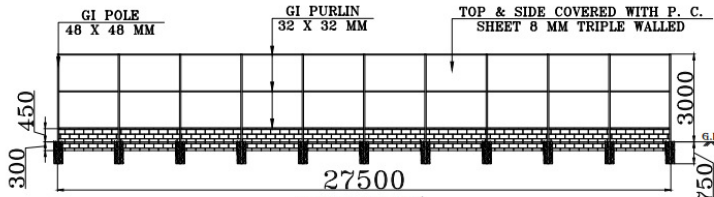

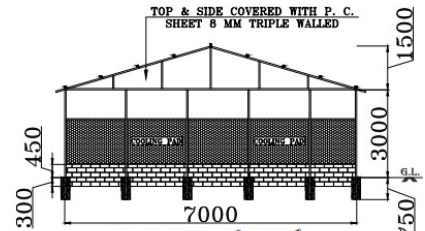

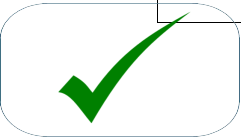
