INSTRUCTIONS TO BIDDER – ONLINE MODE

1. Bidders/Vendors/Suppliers/Contractors must get themselves registered on the portal for participating in the e-tenders published on <https://indiaseeds.enivida.com> by paying the charges of Rs. 2360/- (Inclusive taxes) per year.
2. Bidders must provide the details of PAN number, registration details etc as applicable and submit the related documents. The user id will be activated only after submission of complete details. The activation process will take minimum 24 working hour's enividahelpdesk@gmail.com
3. Bidders must have a valid email id and mobile number.
4. Bidders are required to obtain Class 3 Digital Certificates (Signing & Encryption) as per their company details.
5. Once bidder DSC is mapped with the user id, the same DSC must not be used for another user id on the same portal. However bidder can update the digital certificate to another user id after unmapping it from the exiting user id.
6. Bidders now can login with the activated user Id & DSC for online tender submission process in this portal.
7. Bidders can upload required documents for the tender well in advance under My Documents and these documents can be attached to the tender during tender participation as per the tender requirements. This will save the bid submission duration/time period and reduce upload time of bid documents.
8. Bidders must go through the downloaded tender documents and prepare and upload bid documents as per the requirements of the department.
9. Once the bidders have selected the tenders they are interested in, Bidders will pay the processing fee Rs 550/- per tender (NOT REFUNDABLE) by net-banking / Debit / Credit card then Bidder may download the Bid documents etc. Once Bidders will pay both fee tenders status will be shown “form received”. This would enable the e- tender Portal to intimate the bidders through e-mail in case there is any corrigendum issued to the tender document.
10. Bidders are advised to read complete BoQ/SoQ/Price Bid/Financial Bid and Terms & Conditions before quoting rates in the bid document.

11. Any modification/replacement in BoQ/SoQ/Price Bid/Financial bid template is not allowed. Bidders must quote only in predefined fields in the bid sheet and save the bid sheet. After saving, the same bid sheet must be uploaded in the portal.

SECTION – II

ONLINE TENDER DOCUMENT FOR NSC LTD. PROCESSING PLANTS, IDAR

Online tenders super scribed "TENDER FOR APPOINTMENT OF JOB CONTRACTOR" for the year 2021-22 for NSC, Idar store-cum-seed processing plant is invited on prescribed Tender Form from Labour Contractors registered with labour & EPF/ESI department to undertake the different items of work with tender document. However, in case the valid labour license is not provided along with tender or due for renewal, the contractor will have the liberty to furnish the same within 15 days time from the date of receipt of work order. Even if, the contractor fails to furnish the license within scheduled time, the Corporation will have the right to forfeit their Earnest Money deposit straightway and contractor will have no right for its refund.

TERMS & CONDITIONS

1. The tenderer must fill in their rates both in words and in figures in the tender form. There should be no alternations or over writing in the rates quoted by the contractor. However, if it becomes inevitable the corrections should be made by encircling figures to be altered / over writing duly attested by the contractor. Any correction not attested in any tender form will lead to rejections of the tender.
2. Payment made / credit afforded to the Labour Contractor by NSC from time to time under the contract to be entered in to with the Labour Contractor shall be subject to the deduction of Income Tax at source according to the provision of section 194-C of Income Tax and the rules made there under.
3. Income Tax as per rules will be deducted at source.
4. All the Taxes as applicable shall be borne by the contractor.
5. Under any statutory requirement, contractor will be responsible to bear the EPF and ESI, if any of the laborers provided by him.
6. The Job Contractor should be equipped himself with the sufficient labour force to perform complete the work relating to processing and packing of seeds as per the schedule of work given by Area Manager & Plant In-Charge. The minimum height of stack will be 12th ft.
7. The Job Contractor is allowed to complete the above minimum requirement of seeds delivery in one shift but because of any reasons which are beyond his control, he may complete the above said quantities in 2nd shift or 3rd shift.

8. In the emergency of dispatch of seeds, the Job Contractor has to run two or three shifts or get more laborers or both to cope with the volume of work which is to be completed within specified period without loss of time.
9. The Job Contractor has to be provided required numbers of labours for the job within 18 hours' notice by the concerned Area Manager. If he fails to do so, the job can be performed by other laborers and excess amount paid for it will be deducted from the bill of the contractor.
10. NSC does not guarantee the minimum or maximum workload.
11. The Labour Contractor cannot sublet the above labour contract to any contractor and the Labour Contractor shall remain presence all the time at the Processing Plant during the work.
12. In case the grading work is not found satisfactory by Inspecting Officer, then contractor has to undertake regrading of such quantity up to the satisfaction and no extra payment will be paid to contractor for such work.
13. NSC sublet the contract, if the party shall not give the satisfactory output of day to day work.
14. Job Contractor shall present bills in duplicate duly verified by the In-charge, Processing Plant and the concerned Area Manager. Payment will be made once in a 15 days on monthly basis from the Regional Office, NSC, Gandhinagar through RTGS/NEFT only.
15. The agreement entered into with the labour contractor shall be valid for one year and the same can be renewed with the mutual written consent of the parties if need so. However, in case of failure on the part of Labour Contractor to comply with any of the conditions, the Regional Manager, NSC, Gandhinagar reserves the right to terminate the contract at any time.
16. In case any misconduct or shortcomings by the Labour Contractor or by his labourers which lead to any monetary loss to the Corporation is noticed, the Competent Authority is empowered to recover the loss from contractor and may cancel the contract and the Labour Contractor will have no right to claim for any compensation for misconduct or short-comings by the Labour Contractor or by his labourer.
17. The regular cleaning of wastages outside of the godown at the dust collector shall be the responsibility of the contractor.
18. The contractor is required to maintain full requisite record as per bye-law such as attendance and wages disbursement register in report of laborers provided by the contractor to NSC and the NSC reserve the right to call for such like record for inspection by any of the nominated officer by the RM and labour contractor is obliged to provide the requisite record to the nominated officer without hesitation immediately on receipt of instruction in this regard. In the event of failure on the part for work contractor and contract can be terminated forthwith besides intimating other legalization as is deemed fit by the National Seeds Corporation Ltd.
19. Our Processing Plant comes under the Factory Act, 1948 and accordingly the Contractor has to pay the wages to the minimum wages act of state to the labourers engaged by him for the work at the Processing Plant and such payment register / documents have to be verified by the concerned Area Manager / In charge Processing Plant. In case the contractor will not pay full wages to the concerned labourers according to the Job Contractors Act, 1970, the differences of wages if any will be recovered from the contractor bill / security after arranging payments to the labourers by NSC.
20. The tenders not confirming the prescribed terms & conditions and or conditional tender shall stand rejected. The tenders will be opened on the specified date and time in the presence of such tenderers as may be present. The decision about the acceptance of tenders will be taken on the date of opening of the tenders or as soon as thereafter be possible.

21. The successful tenders shall be intimated by the letters or other means of communication and the tenders so informed shall be bound from the time of transmission of Gandhinagar the acceptance. Formal acceptance of the tenders will be forwarded to successful tenderer in due course but it will serve us merely confirmation of the initial intimation and shall not effect the time from which the offers is/are bound by the contractor(s). The successful tenders is required to enter into an agreement on non-judicial stamp paper of Rs. 500/-. Cost of stamp paper is borne by labour contractor.

22. The Corporation shall not be bound to accept the lowest tender, any and or all the tenders may be rejected without assigning any reason what so ever and Regional Manager. NSC, Gandhinagar reserves the right to reject any or all to accept any or part of the offer made and further he reserves the right to allot specified jobs to different tenders and split the job without assigning any reasons. The decision of the NSC Gandhinagar in the matter shall be final and binding in all respects and it will not be challengeable by any of the tender.

23. The tenders received from black listed labour contractor by NSC or any other Govt. department shall not be considered. Notarized affidavit in this respect must be submitted by tenderer.

24. The cost of tender form is Rs. 1180/- per set (Not refundable) will be paid online

25. The online Tender forms shall be accepted by NSC Ltd. Gandhinagar up to 14:00 hrs of 06.07.2022. and will be opened on the same day at 15:00 hrs in presence of the tenderer of their representative, if any. In case tender opening date happens to be holiday, than tender will be accepted and opened on next working day at same time.

26. The contract may be discontinued at any time at the desecration of Regional Manager and without assigning any reason.

27. NSC also reserves the right to terminate the contract and forfeit the security of the contractor if the performance of the contractor is not found satisfactory.

28. In the event of any difference or dispute arising out of or in connection with the agreement entered into with the Job Contractor, the same will be referred to the jurisdiction of a Sole Arbitrator to be nominated by the Chairman-cum-Managing Director of NSC on application being made to him by either of the parties. There shall be no objection to such person being nominated as an Arbitrator being in any manner concerned with either NSC or the Government of India or any other Government Undertaking. The Arbitrator so appointed shall have the power to decide and determine its own procedure and shall make an award in such time as may be possible in the circumstances of the case.

29. The parties hereby agree that in the event of any dispute, no cause of action shall arise in their favour to approach any court unless they have resorted to an exhausted the remedy of arbitration as envisaged above.

30. An earnest money deposit (EMD) of Rs.30,000/- (Thirty Thousand only) will be deposited online.

31. The 2% of the net amount payable to contractor per bill will be retained by National Seeds Corporation Limited as retention money (Security Money) and shall be refund to contractor on completion of contract satisfactorily along with EMD, both without interest.

32. The Security deposit will be discharged by the corporation and returned to the contractor the date of completion of the contract. They have no claim in respect of the contract or relating there to or arising there from against NSC.

33. Contractor has to attend processing plant work under the terms & conditions of NIT and as per instructions of Area Manager NSC, Idar and execute an agreement on non-judicial stamp paper of Rs.500/- under the clause No. 21. The contractor will ensure renewal of License validity, EPF Code, ESI Code time to time within the time frame of work order & ensure payments to labours and deposit EPF / ESI, Challans, etc. timely.

34. All disputes in relation to the tender, the contract or the interpretation of any of their terms or implementation there-of arising out of or concerned directly or indirectly with the contract/tender shall be referred to the Sole arbitrator to be appointed by the Chairman-cum-Managing Director of the Corporation/ purchaser and in the absence of CMD, the highest Executive Officer of the Corporation shall make such appointment. The venue of arbitration shall be at New Delhi. The court of law at the New Delhi / Delhi alone will have jurisdiction in the matter of any disputes whatsoever. The arbitrator shall have powers to enlarge time for making & publishing the award with the consent of the parties. The parties will have no objection to the appointment of the arbitrator on the ground that the arbitrator had dealt with the matter of any earlier stage. In case the supplier is a Public Sector Undertaking, the above clause shall not be applicable and in that event the following clause shall apply. In the event of any dispute or difference relating to the interpretation and application of the provisions of the contracts, such dispute or difference shall be referred by either party to the arbitration of one of the arbitrator in the Department of Public Enterprises to be nominated by the Secretary to the Govt. Of India, In charge of the Bureau of Public Enterprises. The arbitration & Reconciliation Act 1996 shall not be applicable to the arbitration under this clause. The award of the Arbitrator shall be binding upon the parties to the dispute, provided however any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Department of Legal and Affairs, Ministry of Law and Justice, Govt. of India. Upon such reference, the dispute shall be decided by the Law Secretary or the Special Secretary/Additional Secretary when so authorized by the Law Secretary whose decision shall bind the parties finally and conclusively. The parties to the disputes will share equally the cost of arbitration as intimated by the Arbitrator.

35. In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of arbitration & conciliation Act, 1996 as amended from time to time under this provision, the Chairman-cum-Managing Director, National Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall in English Language. The court of Delhi shall have the jurisdiction.
