Instruction to Tenderers

TERMS & CONDITIONS OF THE CONTRACT

- The tenders are being invited by Regional Manager, National Seeds Corporation, NSC, Kolkata.
- 2. The contractor should read the terms & conditions carefully before submitting tender.
- 3. The earnest money and Tender Fee should be submitted online along with tender documents.
- 4. Micro small enterprises MSE's registered with NSIC or any other body specified by Ministry of MSME, for such works are exempted from payment of Tender fee as well as EMD subject to furnishing valid documentary proof in support of their claim along with their request.
- 5. The tenderer will be required to upload Certificate of registration of the firm, PAN, Income Tax Return, Audited Balance Sheet, Profit & Loss statement for the last 3 year and Registration No. of GST, PF, ESI Registration and work done certificates, etc. as per tender terms.
- **6.** The contractor will have to give an undertaking that he will submit the proof of remittance of PF through challan at the time of bill payment. In case of non furnishing of such proof, 4.7% (four point seven percent) of the value of the bill amount of work shall be withheld by NSC which can be released only after production of the required document.

If it is incumbent upon NSC to deposit withhold amount with EPF authorities, the same shall be deposited by NSC with EPF authorities. After deposition of the amount, NSC shall not refund this to the contractor even on production of EPF Challans.

- 7. NSC shall also recover labour Cess @ 1% from each RA bill and shall deposit with the Labour Board of the concerned state. In case the Labour Board is not established in the state, recovery made by NSC shall be retained under suspense and will be deposited with the Labor Board as & when established in the state.
- 8. GST or any other tax applicable on material in respect of this contract shall be payable by the contractor and no claim whatsoever in this respect will be entertained
- 9. The rates quoted by the contractor are in -------% **above** and **below** against the estimated cost referred in Schedule of the tender will be taken as correct and not the amounts worked out by them.

- 10. Time allowed for carrying out the work will be **120 Days** from the date of receipt of acceptance of work order. The acceptance of work order should be submitted within 2-3 days from the date of issuance of order.
- 11. Tenders must be submitted online up to 11.08.2022 upto 14.30 hours and Technical bids will be opened at 15.00 hours on same day at above mentioned address in presence of tenderer who wish to attend.
- 12. Tender should remain open for acceptance for a period of 90 days from the date of receipt of tender. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which are not acceptable to the department, then the corporation shall, without prejudice to any other right or remedy, be at liberty to forfeit the earnest money as aforesaid.
- 13. Tenders who do not fulfill all or any of the above conditions or incomplete tenders in any respect are liable to be summarily rejected.
- 14. The tenders containing unsealed remarks or any additional conditions are liable to summarily rejection.
- 15. Mobilization advance shall not be applicable.
- 16. The contractor should visit the site and shall satisfy himself to the conditions, the accessibility of site, the full extent and character of operation, the nature of the ground and supply conditions affecting lay out execution of the contract generally. No claim on the ground for want of knowledge in such respect will be entertained.
- 17. Change in the terms and condition, or schedule of completion shall not be accepted such conditional tenders shall be liable for rejection.
- 18. Cutting/overwriting in the offer must be avoided as may be lead to cancellation of Tender. However in the case of any cutting, it should be authenticated by signature of the tenderer concerned.
- 19. The rates shall be inclusive up to all heights, materials, labours, tools & plants and taxes etc. as per site condition.
- 20. Mixing of cement concrete and cement mortar shall be done by means of mechanical mixer. The cement concrete laid shall be mechanically vibrated by means of mechanically operated vibrators. The rates quoted shall be inclusive of these operations and no extra payments shall be made.
- 21. The receipt of clerk for any money paid by the contractor will not be considered as any acknowledgement or payment to the National Seeds Corporation and the contractor shall be responsible for seeing that he procures a receipt signed by the Accountant/Engineer or a duly authorized Cashier.

- 22. The contractor shall give a list of NSC employees related to him.
- 23. The successful tenderer shall deposit performance guarantee @ 03% of accepted value of work within 15 days of letter issued in this regard. This guarantee bond shall be in the form of Demand Draft or by means of Bank Guarantee as per proforma attached at Section-III Part-A of the tender document. The Bank Guarantee shall issued by any Nationalised Bank only. The Bank Guarantee should be accompanied by a forwarding letter of the banker on their letter head. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 days beyond that. In case the time for completion of work gets extended, the supplier shall get the validity of performance guarantee extended to cover such extended time for completion of work. After recording of the completion of certificate for the work by the competent authority, the performance guarantee shall be returned to the contractor, without any interest.
- **24.**The **security deposit** shall be dubitable @ 10% from the bills and will remains as such for a period of defect liability from the date of completion of work. **Defect liability period will be twelve months.**
- 25. Defects arising during the defect liability guarantee period if any shall be rectified by the party free of cost with in fortnight as and when brought to the notice in writing or telephonically.
- 26. The contractor's responsibility for this contract shall commence from the date of issue of order of acceptance of tender.
- 27. The contractor shall maintain and produces all records when called for, related to relevant Acts concerning labour engaged and construction.
- 28. An undertaking on company letter head, stating that the firm is not black listed by Govt. Deptt./ Public Enterprises/ Govt. Undertaking etc. in prescribed format given at Annexure-A1.
- 29. An affidavit on Rs 100 non judicial stamp paper as per Annexure-A2.
- 30. **Agreement:** The successful tenderer shall, within 15 days of having been called upon by notice to do so, be bound to execute a formal agreement as per the format given in Section-III Part-A of the tender document. The terms & conditions contained in Section-I of Part-A of the tender document will be construe to be part of the agreement. Any variation in the terms & conditions as may be suggested by the tenderer and accepted by the Corporation will be specifically mentioned in the agreement. The cost of stamping for agreement should not be less than Rs.100/- which shall be borne by the successful tenderer.
- 31. **LIQUIDATED DAMAGES** Time of work completion stipulated in the contract is the essence of the contract. It is admitted by the contractor that any delay in work completion will cause damages to the corporation/purchaser, the contractor hereby agrees that the corporation/purchaser shall suffer damages at the rate of **0.5**% (half per cent) on the contract price per week of delay, subjected to a maximum of **10**% (ten per

cent) **of the contract price** and it shall be deemed to be the actual damage suffered by the corporation/purchaser. The contractor undertakes that if he fails to complete the work by the time specified in the order, the contractor shall become liable to pay damages at the above rate and shall continue to incur liability to pay damages as the delay increases. The payment of deduction of such damages shall not relieve the contractor from his obligation to complete the works, or from any other of his obligations and liabilities under the contract.

32. Refund of Earnest Money:

A. Unsuccessful Tenderers

In case of unsuccessful tenderers who do not withdraw their offers before the receipt of final decision, the earnest money shall be returned without interest after the finalization of tenders.

B. Successful Tenderers

After the successful tenders have completed all formalities as stated ,the earnest money deposit shall be refunded to him.

- 33. The Corporation shall have the right of rejecting all or any of the tender without assigning any reason whatsoever and will not be bound to accept the lowest tender or any of the tender.
- 34. If any item of work is required to do as directed by Engineer in Charge which is not in schedule of items. In this case rate of that item will be fixed rate of DSR'21 plus or minus rate quoted by contractor on DSR'21.
- **35.Arbitration-** In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual, understanding and discussion. In case, dispute remains even after discussions, then it sholl be binding upon parties to resolve issue under the provisions of Arbitration & Conciliation Act, 1996 amended from time to time. Under this provision, the chairman-cum-Managing Director' National seeds corporation Limited with the concurrence of both the parties shall appoint sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of low. The Arbitration shall be conducted to New Delhi and shall in English Language. The court of Dethi shall have the jurisdiction.
