## **INSTRUCTIONS TO THE BIDDER'S**

1. Bidders/Vendors/Suppliers/Contractors must get themselves registered on the portal for participating in the e-tenders published on <https://indiaseeds.enivida.com> by paying the charges of Rs. 2360/- (Inclusive taxes) per year.
2. Bidders must provide the details of PAN number, registration details etc as applicable and submit the related documents. The user id will be activated only after submission of complete details. The activation process will take minimum 24 working hour's [enividahelpdesk@gmail.com](mailto:enividahelpdesk@gmail.com)
3. Bidders must have a valid email id and mobile number.
4. Bidders are required to obtain Class 3 Digital Certificates (Signing & Encryption) as per their company details.
5. Once bidder DSC is mapped with the user id, the same DSC must not be used for another user id on the same portal. However bidder can update the digital certificate to another user id after un-mapping it from the exiting user id.
6. Bidders now can login with the activated user Id & DSC for online tender submission process in this portal.
7. Bidders can upload required documents for the tender well in advance under My Documents and these documents can be attached to the tender during tender participation as per the tender requirements. This will save the bid submission duration/time period and reduce upload time of bid documents.
8. Bidders must go through the downloaded tender documents and prepare and upload bid documents as per the requirements of the department.
9. Once the bidders have selected the tenders they are interested in, Bidders will pay the processing fee Rs 550/- per tender (NOT REFUNDABLE) by net-banking / Debit / Credit card then Bidder may download the Bid documents etc. Once Bidders will pay both fee tenders status will be shown "form received". This would enable the e- tender Portal to intimate the bidders through e-mail in case there is any corrigendum issued to the tender document.
10. Bidders are advised to read complete BoQ / SoQ / Price Bid / Financial Bid and Terms & Conditions before quoting rates in the bid document.
11. Any modification/replacement in BoQ / SoQ/ Price Bid / Financial bid template is not allowed. Bidders must quote only in predefined fields in the bid sheet and save the Bid-Sheet. After saving, the same bid sheet must be uploaded in the portal.
12. Bidders must pay required payments (Tender fee, EMD, Tender Processing Fee etc.,) as mentioned in the tender document, before submitting the bid.
13. Bidders are recommended to use PDF files for uploading the documents. Only price bid sheet will be in Excel format.

14. The bidders must ensure to get themselves registered on the portal at least ONE Week before the tender submission date and get trained on the online tender submission process. For tender submission and registration process bidders are advised to refer respective manuals on website. Tender inviting Authority/Department will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders due to local issues like internet connectivity/PC speed/etc...
15. Offline Submission of bids/documents/rates by the bidders will not be accepted by the department, under any circumstance.
16. After final submission of the bid, a confirmation message and bid submission acknowledgement will be generated by the portal. The bid submission acknowledgement contains details of all documents submitted along with bid summary, token number, date & time of submission of the bid and other relevant details. Bidder can keep print of the bid submission acknowledgement.
17. If bidder is resubmitting the bid, bidder must confirm existence of all the required documents, financial bid and again submit the bid. Once submitted, the bid will be updated.
18. Submission of the bid means that the bid is saved online; but system does not confirm correctness of the bid. Correctness of the bid will be decided by tender inviting authority only.
19. The time displayed in the server is IST (GMT 5:30) and same will be considered for all the tendering activities. Bidders must consider the server time for submission of bids.
20. Bid documents being entered by the Bidders/Vendors/Contractors will be encrypted at the client end and the software uses PKI encryption techniques to ensure security/secrecy of the data. The submitted bid documents/data become readable only after tender opening by the authorized individual.

## **ADDITIONAL INSTRUCTIONS FOR VENDORS**

The bidders are required to submit soft copies of their bid electronically on the E- nivida Portal using valid Digital Signature Certificates. Below mentioned instructions are meant to guide the bidders for registration on the E-nivida Portal, prepare their bids in accordance with the requirements and submit their bids online on the E-nivida Portal. For more information, bidders may visit the Portal (<https://indiaseeds.enivida.com>)

### **1. REGISTRATION PROCESS ON ONLINE PORTAL**

- (a) Bidders to enrol on the E-nivida module of the portal <https://indiaseeds.enivida.com>. By clicking on the link “Bidder Enrolment”.
- (b) The bidders to choose a unique username and assign a password for their accounts. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. This would be used for any communication from the e-nivida Portal.
- (c) Bidders to register upon enrolment, with their valid Digital Signature Certificate (Class III Certificates with signing and Encryption key) issued by any Certifying Authority recognized by CCA India with their profile.
- (d) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- (e) Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token.

- (g) As per portal norms Registration Fee will be applicable.

### **2. TENDER DOCUMENTS SEARCH**

- (a) Various built-in options are available in the e-Wizard Portal like Department name, Tender category, estimated value, Date, other keywords, etc. to search for a tender published on the Online Portal.
- (b) Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective ‘Interested tenders’ folder.
- (c) The bidder should make a note of the unique Tender No assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.

### **3. BID PREPARATION**

- (a) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- (b) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.
- (c) Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that needs to be submitted. Any deviations from these may lead to rejection of the bid.

- (d) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLSX/PNG, etc. formats.

#### **4. BID SUBMISSION**

- (a) Bidder to log into the site well in advance for bid submission so that he/she uploads the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- (b) The bidder to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- (c) Bidders to note that they should necessarily submit their financial bids in the prescribed format given by department and no other format is acceptable.
- (d) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, the opening of bids, etc. The bidders should follow this time during bid submission.
- (e) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data, which cannot be viewed by unauthorized persons until the time of bid opening.
- (f) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- (g) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- (h) The off-line tender shall not be accepted and no request in this regard will be entertained whatsoever.

National Seeds Corporation Limited (NSC) requires fresh, good quality, processed Certified seeds of Soybean, Hybrid Sunflower and Certified/Truthfully labelled seeds of Groundnut on consignment supply basis for supply to Karnataka State Department of Agriculture (KSDA) /Other Government Departments for distribution during Kharif 2023.

Each EOI Supplier has to submit bid in two bid system.

**Procedure for submission of EOI (online):**

1. **TECHNICAL BID:**

The TECHNICAL BID shall be submitted as per PART A, this contains the details of organisation, company profile, details of experience, EMD etc.

2. **FINANCIAL BID**

Each Supplier has to quote financial offers on per quintal basis as per PART B in e-portal.

**Short term e-procurement EOI for purchase of Certified seeds of Soybean, Hybrid Sunflower and Certified/Truthfully labelled seeds of Groundnut from reputed seed producers.**

**GENERAL TERMS & CONDITIONS OF TENDER**

1. Rate shall be quoted in Rs. Per Qtl **FOR Karnataka on consignment basis** for the fresh, net final cleaned/graded, tested and packed quantity in NSC packing (exclusive of bag weight) including NSC service margin. The rate shall be inclusive of packing material, producer labels and other claim on taxes, if any liveable, shall not be entertained. The packing design and matter to be printed on the bags will be provided by NSC.

The seeds required by NSC for supply during Kharif 2023 are detailed below.

**Note:**

**\*Quantities mentioned are only tentative; NSC may increase or decrease final required quantities.**

**\*The packing size should be as per the requirement of the Department of Agriculture, Karnataka and out of the offered quantity 20% of the quantity to be packed in half acre packing based on the department requirement.**

**\*If the department insists for supply of TL seeds in case of non-availability of certified seeds, consent will be given to the department for supply and suppliers should arrange for the same.**

2. The Suppliers shall supply the seeds offered by them under this e-procurement EOI to the Karnataka State Department of Agriculture (KSDA) /other Departments during Kharif-2023 for distribution under subsidy or any other programmes and shall agree to supply the seeds at the rates finalised by the rate fixation committee of KSDA or other Department for Kharif 2023.

3. **NSC Service Margin:** The service margin of 3 % of total seed value is to be payable to NSC for the quantities sold by NSC. **If any PACS/FPO commission to be paid to the department, the same should be borne by the supplier.**

4. Suppliers having minimum of two years experience in supply of Soybean, Sunflower and Groundnut seeds to Department/PSUs are eligible to participate in the EOI.
5. The EOI shall be accompanied by interest free EMD (as mentioned in clause no. 1 of Part B) through NEFT/RTGS after generating E- Challan from <https://indiaseeds.enivida.com> or through bank guarantee or by submitting Insurance surety bond as a substitute for Bank guarantee. Suppliers without EMD may be rejected. EMD of technically disqualified tenderers will be returned through RTGS within 45 days of tender opening. EMD of those tenderers who do not accept to supply the seeds at rates finalised by the department (except those tenderers who quoted less than the department finalised rate) will be returned through RTGS within 30 days of non-acceptance. Outstanding amount, if any, of the supplier with NSC will not be considered for the EMD purpose. Only MSME's are exempted for payment of EMD subject to valid documentary proof of registration with NSIC.
6. EOI Supplier may upload their bid up to 2.00 PM. on **25.02.2023** and technical bids will be opened on the same date and place at 3.00 PM. in the presence of those suppliers who may wish to be present. Financial Bids will be opened for those whose Technical Bid will be in order as per EOI. Bids received after the due date and time may be rejected.
7. The Supplier's offer shall be **valid up to 31<sup>st</sup> October 2023 or for an extended period as sought by the department.**
8. The quantity offered should be for at least 25 % of total required quantity of relevant variety. Delivery of the entire quantity offered by the Supplier and agreed by NSC should be as per supply schedule. Failure to delivery 90% of the quantity approved by NSC shall entitle NSC to impose penalty @ 10% of the value of the shortfall in the supply at the rate agreed to. For delayed supplies penalty of Rs. 2/- per day per Qtl. will be charged.
9. The successful supplier shall remit interest free Security Deposit @ 3 % of the total value of the supply at the approved rate through NEFT/RTGS or through bank guarantee or by submitting Insurance surety bond as a substitute for Bank guarantee. This deposit shall be remitted within five working days from the date of receiving the NSC's purchase order / intimation. EMD of the successful supplier can be adjusted in the security deposit. Failure to remit the Security Deposit, the same will be deducted from your first bill as Security deposit for the supplied quantities and will be released only after completion of total transactions.
10. The successful supplier shall at his cost execute an Agreement with NSC on Rs.200/- non-judicial stamp paper of required value for arranging the supply as per the Terms and Conditions, sign each page of the Terms & Conditions and submit the same to NSC along with the Security Deposit.
11. **a. If the rate finalised by the department is less than the L1 rate received in this EOI then, negotiation will be done with all technically qualified bidders for acceptance to supply at department rate with 3 % service margin to NSC.**

**b. If the department finalised rate is higher than the L1 rate received in this EOI then, there will be no upward revision of the L1 rate and L1 party should supply the seeds at his quoted rate only with 3 % service margin to NSC and other technically qualified bidders will also be asked for acceptance to supply at the L1 rate.**

**c. NSC may accept more than one supplier in order to ensure multiple sources and quantity to be purchased from individual supplier will be decided by NSC.**

12. All seeds offered for supply should be treated with the following Seed treatment chemicals as per the standards fixed:

Sl. No.	Crop	Chemical
1	Soybean	<i>Trichoderma Viridae</i>
2	Sunflower	<i>Trichoderma Viridae</i>
3	Groundnut	<i>Trichoderma Viridae</i>

If seeds are not treated at the time of packing, a packet containing sufficient quantity of chemical as per the recommended dose shall be kept inside each of the seed packet to enable the farmers to treat the seeds before sowing. A pamphlet in Kannada giving warning about chemical and the procedure to treat the seed should be kept inside the seed packet along with sachet.

13. The seed shall be fresh, processed and packed as per NSC's requirement at the supplier's premises at his cost and expense. NSC shall have the right to inspect the operations from time to time.
14. The supplier and NSC will jointly arrange for the Seed Certification Agency's permission for packing the offered/accepted quantity in NSC bags.
15. a) **Truthfully labelled (TL) seeds:** The supplier shall make available to NSC a copy of the test reports from the notified seed testing lab regarding germination and other specified standards as per Seed Act for each lot before delivery to NSC.
- b) **Certified Seeds:** The supplier shall make available to NSC a copy of Release orders (FORM II) and Area Registration certificate issued by State Seed Certification Agency.
16. NSC will draw representative samples of the final cleaned / graded seed lots offered by the supplier and have then analysed in NSC's Quality Control Laboratory (QCL) or any other laboratory identified by NSC. **Only the lot cleared both in state approved lab and NSC QCL lab for certified seeds and NSC QCL lab for TL seeds will be finally accepted by NSC for procurement.**
17. The supplier will arrange packing material, producer labels, thread, lead seal, and arranging packing, i.e. Seed treatment, weighment, labelling & tagging, sealing, stacking etc at his cost under the supervision of NSC official. A leaflet indicating package of practices in

Kannada to be placed in the seed packet. If the department insist for any changes in supply, the supplier should be ready to incorporate the same.

18. The seed stock shall conform to the quality and quantity specifications prescribed in the Minimum Seed Certification Standards 2013, as amended from time to time and shall possess good physical appearance, free from ODV, insect infestation and lustre to NSC's satisfaction.
19. The Seed is to be supplied in time as per the order of NSC; if any delay the seeds will not be accepted.
20. Supplier's failure to arrange the supply as per the terms & conditions will entitle NSC to cancel the order and arrange from other suppliers in the tender at the cost and risk of the defaulting supplier.
21. NSC may increase the final requirement up to 100 % from the quantity mentioned in the EOI with the consent of the supplier. For additional quantity, NSC will issue the order after remitting the additional security deposit.
22. **QR Coding** is compulsory on both primary and secondary packaging for all crops seeds including varieties/hybrids. (Primary means each single unit of package that will carry seeds. Secondary pack will be the bigger bag that will carry multiple units of primary packs). Suppliers should obtain Unique Product Identification code (GTIN). The GTIN will be encoded within the QR code.

\*Global Trade Item Number [GTIN] is the identification standard [ISO/IEC 15459-6] that enables unique and universal identification of the products in the open supply chain.

**List of attributes which need to be encoded in a QR code:**

1. Global Trade Item Number (GTIN): It includes
    - a) Producer Company Name
    - b) Distributor/Dealer Company Name
    - c) Crop Name
    - d) Variety/Hybrid Name
    - e) Weight in Kgs
    - f) MRP in Rs.
  2. Batch/Lot No: It includes
    - a) Date of packing
    - b) Expiry Date
  3. URL Link.
  4. Serial Shipping Container Code (SSCC): Secondary packaging should contain SSCC.
23. After receipt of farmer share from the Department / Consignee, NSC will release the same to supplier through RTGS within 30 days from submission of bills after deducting NSC service margin (3%) subject to fulfilling the requirements set out in the terms & conditions.

24. After receipt of government share, the same will be released and security deposit will be released only after completion of total transactions.
25. If the department/consignee not released any payment (Farmer share/Government share/both) due to quality complaints, the same will be kept on hold till the complaints get resolved.
26. The Supplier shall, at his cost, take back part or full quantity of such stock proved defective on receipt by / delivery to NSC or unsold quantity (Consignment basis). In the event of any dispute / complaint with reference to the seed quality, if the responsibility of the supplier is proved / established, he shall bear the loss / damage, if any sustained by NSC to relevant extent.
27. The supplier shall indemnify the NSC, KSDA, other Departments and the farmers from all the quality problems arising out of the seed supplied by the suppliers.
28. The suppliers should also abide by all the terms and conditions of the department tender.
29. Conditional offers shall not be accepted and the Tenderer shall not impose any additional terms / conditions.
30. NSC reserves the right to accept / reject any or all the tenders without assigning any reason what-so-ever. NSC further reserves the right to award the EOI to more than one Supplier. NSC has the right to modify / delete / add any terms & conditions of EOI supply as well as agreement to be executed after awarding of quantities to the Suppliers.
31. **FORCE MAJEURE CLAUSE:** Notwithstanding the provisions of GCC clauses, the EOI shall not be liable for termination for default, if and to the extent that, its delay in performance or failure to perform its obligations under the contract is the result of an event of force majeure as notified by the Government. For purposes of this clause, **“Force majeure”** means, an event beyond the control of the service provider and not involving the EOI provide a fault or negligence and not feasible. Such events may include, but are not limited to, acts of the procurement entity either in its sovereign or contractual capacity, wars or revolutions, fires, floods epidemics, quarantine restrictions and freight embargoes. If a force majeure situation arises, the supplier shall promptly notify the procurement entity in writing of such conditions and the cause thereof, unless otherwise directed by the procurement entity in writing, the Service provider shall seek all reasonable alternative means for performance not prevented by the force majeure event.
32. In case of any dispute arises between NSC and other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, disputes remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration and conciliation Act, 1996 as amended from time to time. Under this provision, the Chairman-cum-Managing Director, National Seeds



Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall be in English Language. The court of Delhi shall have the jurisdiction.

**OTHER TERMS & CONDITIONS.**

1. NSC shall not be responsible for fluctuation of the market rate of the ordered seed. The Tenderer shall be required to supply the seed at agreed rate only. The agreement can be terminated at any time due to non-performance of any of the terms & conditions of the agreement to the satisfaction of the Corporation.
