TERMS & CONDITIONS

1. The Tender Documents with tender form along with complete details can be purchased from this office and our above Area Offices on payment of Rs.1180/- (including GST). The Tenders duly sealed along with Demand Draft in favour of National Seeds Corporation Ltd. payable at Pune (for EMD & cost of tender) should be submitted up to 01.00 PM on 14.03.2023 at Regional Office, Market Yard, Pune. **The cost of tender & EMD can also be transfer to NSC SBI Account No.32919549520 IFSC Code SBIN0006117 Branch Market Yard, Pune.** The Tenders so received shall be opened by the Committee on the same day (if Possible) i.e. on 14.03.2023 at 02.30PM in the presence of Tenderers / their representatives at Regional Office, NSC, Pune.
2. Tender must be accompanied with EMD of Rs. 3,00,000/- in the form of DD in favour of National Seeds Corporation Ltd, payable at Pune. Tender without EMD will be rejected. No interest will be paid on EMD. **The EMD can also be transfer to NSC SBI Account No.32919549520 IFSC Code SBIN0006117 Branch Market Yard, Pune.**
3. The Tender should be submitted only after agreeing with all the terms and conditions. For acceptance of terms and conditions, he is required to sign on all pages. They should submit the Tender in two envelopes i.e (1) in first envelope Technical Bid accompanying with Demand Draft (EMD & cost of tender), Declaration Form, Xerox copies of PAN Card, Trade License, Sales Tax Registration. GST Registration etc. (2) In second envelope i.e. Financial Bid only Rate in specific Tender Form is submitted. These two separate envelopes should be put in one envelope and be put in Tender Box.
4. The stock is available for sale on **“AS IS WHERE IS BASIS”**. The stock is available for inspection by the parties between 10.00 AM to 5.30 PM on any working day at the concerned Area Offices. They may contact Area Manager of concerned NSC Offices.
5. All seeds are packed in different packing sizes on **“AS IS WHERE IS BASIS”**. The arrangements for lifting the seeds will be made by the Tenderer at his own

cost. The cost of removing tags, labels, seals & defacing of bags will be borne by the Tenderer and Area Manger concerned should be advised to remove all tags, labels, seals and deface the bags before delivery of the seed. The stocks shall be supplied only after removing tags, labels, seals etc in open condition.

6. Offer should be valid at least for one month but lifting of entire quantity by the Tenderer is required to be completed within 15 days of issue of NSC's order from the mentioned destinations after paying 100% cost failing which storage charges @ Rs.25/- per quintal/month shall be charged from the tenderer.
7. Lifting of seed shall be made from above stocking points after making 100% payment. Labour charges, loading / unloading charges if any on this account shall be borne by the purchaser. If the tenderer wants to lift the material with bags he should deposit Rs.10/- per bag of more than 20 Kg. size and Rs.5/- per bag for less than 20 Kg. size bags.
8. In case successful tenderer fails to lift the quantity as per supply order Penalty may be imposed and EMD will be forfeited.
9. GST/Taxes, if any shall be borne by the Tenderer.
10. Conditional /Telegraphic / Fax Tenders will not be accepted.
11. Any difference or dispute arising out of or in connection with the tender shall be decided by the Arbitrator. The Chairman-cum-Managing Director, NSC shall be sole Arbitrator and the Arbitrator's decision shall be final and binding to the parties.
12. The Corporation is not bound to accept the highest quotation. Any or all the quotations may be rejected without assigning any reason thereof. The Corporation also reserves the right to accept in whole or part of the offers made. The decision of the Corporation in this matter shall be final and binding to all.
