TWO BID SYSTEM FOR TENDER

Two independent sealed envelopes should be prepared for participation in the tender, as mentioned below:

ENVELOPE NO.1 (SEALED)

This envelope should be marked as 'ENVELOPE NO.1 – TECHNICAL BID FOR DISPOSAL OF NON-SEED' and should contain in "ANNEXURE-I" (Technical Bid) EMD details, Duly signed copy of tender document, Declaration Form, Xerox copies of PAN Card, GST Registration etc.

These two separate envelopes should be put in one envelope super-scribed as "Tender for Non- Seed" and addressed to the

ENVELOPE NO.2 (SEALED)

This envelope should be marked as 'ENVELOPE NO.2 – FINANCIAL BID FOR DISPOSAL OF NON-SEED' and should contain "ANNEXURE-I" only Rate in specific Tender Form is submitted.

Both the envelopes should be placed in one big sealed envelope superscribing "BID OF TENDER FOR DISPOSAL OF NON-SEED" The sealed bids should be delivered in the office of the Regional Manager, NSC, Plot No.-24, Phase-9, Industrial Area, Mohali -160062 at 10:00 AM to 5:30 PM on working days up to 10.08.2023, 1:00 PM.

The bidder must affix seal and put address on each envelope.

Detailed Terms and Conditions of the Tender for Sale of Non Seed

1. The Tender Documents with tender form along with complete details can be purchased from this office (NSC, Plot No.-24, Phase-9, Industrial Area, Mohali (Punjab) - 160062) and our concerned area offices (NSC Karnal, Jalandhar & PC Bathinda) on payment of Rs.1180/- (including GST). The EMD amount Rs. 5000/- and tender form fee Rs. 1180/- along with GST and other taxes, should be deposited by the bidder via RTGS/NEFT for participating in the tender. The EMD of unsuccessful bidder will be returned without any interest on such amount after receiving refund request from the bidder. The EMD of successful bidders will be converted into security deposits which will be returned without any interest, after successful completion of work.
2. The tender should be submitted only after agreeing with all the terms & conditions and the bidder has to submit duly signed & stamped copy of tender documents (all pages of tender).
3. Bids received within the due date and time only will be entertained.
4. Bidder cannot withdraw their offer once it is submitted to NSC.
5. The stock is available for inspection by the parties/ bidders between 10:00 AM to 5:30 PM on any working day at the concerned area offices/ stocking place. They may contact Area Managers of the concerned NSC Offices prior to inspection.
6. The non-seed offered for sale through tender is strictly on “**AS IS WHERE IS BASIS**” and NSC reserves the right to include or exclude any quantity.
7. The evaluation of financial bid shall be on highest quoted rate.
8. The successful bidder shall have to deposit whole amount at once after issue of work order within five working days via RTGS/NEFT along with GST and other taxes, if any.
9. The cost of collection, loading/ unloading, labour charges & transportation etc. will be completely borne by the bidder only.
10. The loaded tractor/ truck should carry a **Gate Pass** issued by the concerned unit *I/C*.
11. **Any kind of taxes will be borne by the bidder only.**
12. The work of seed lifting by the successful bidder shall be completed within 7 working days from the date of issuance of work order on working days between 10:00 AM to 5.30 PM, failing which storage charges @ Rs.25/- per quintal/week shall be charged from the bidder.
13. If the bidder wants to lift the material with bags he should deposit Rs.20/- per bag of more than 20 Kg. size and Rs.10/- per bag for less than 20 Kg. size bags.
14. NSC reserves the right to accept or reject any/all tenders without assigning any reason whatsoever.
15. In case successful bidder denies to lift the quantity as per supply order Penalty may be imposed and EMD will be forfeited.
16. The bidder required to submit a declaration (Annexure-III) on Non- Judicial stamp paper of Rs.100/- duly notarized.
17. In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration & Conciliation Act, 1996 as amended from time to time. Under this provision, the Chairman-cum-Managing Director, National Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall in English Language. The court of Delhi shall have the jurisdiction.
