**E-tender norms**

1. It is mandatory for the tenderers / contractors to have their PAN number and Aadhar number, which can be tendered. Must be attached with the form. Must have Registration Certificate in EPF ESIC.

2. 10,000/- EMD should be deposited by the tenderer in the form of Bank Demand Draft in favor of National Seeds, Nigam Limited, Jetsar and in the name of State Bank of India, Bajuwala, which will have to be deposited with the form cashier before tendering. . Earnest Money RTGS The CSF Jetsar's account number- 41532435884 should also be deposited in the IFSC code SBIN0008251. Whose UTR Number to be provided to the tenderer.

The earnest money will be refunded to unsuccessful tenderers without interest. If the contractor fails to comply with the terms and conditions, the earnest money deposited shall be forfeited. of successful tender

The earnest money will be kept as a security deposit. On which no interest will be payable.

3. Initially the tenure of the contract is one year, which may be extended for another two years on year to year basis, if required. If the work of the contractor remains unsatisfactory, the Competent Officer of Jetsar Farm at his discretion can terminate the contract on one month's notice.

4. The bills payable by the contractor will be paid within 15 days of working day after deducting any taxes.

5. Industrial Disputes Act 1947 Contract Labor (Regulation and Abolition) Act 1970 Minimum Wages Act Workmen's Compensation Act and the statutory liability of proportionate to the provisions of the laws, rules and regulations in force from time to time shall be the sole responsibility of the contractor and all EPF, ESI deposits. It will be the responsibility of the contractor to make it happen.

6. If any accident or accident occurs during the course of the contract work, the contractor will be solely responsible for that.

7. Valid Labor License as well as establishment certificate is necessary.

8. It is necessary to give at least four workers at a time by the contractor for the smooth running of the work, which can also be increased as per the requirement.

9. If there is any complaint in getting the work done by the contractor or if the work is not done on time, then the concerned department will have the right to deduct 20 percent from the earnest money deposited as a penalty.

10. In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions. Then it shall be binding upon parties to resolve issue under the provisions of Arbitration & Conciliation Act, 1996 as amended from time to time under this provision, the chairman-cum-Managing Director, National Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The arbitration shall be conducted at New Delhi and shall in English Language. The Court of Delhi shall have the Jurisdiction
